MIN. QTY.	Item	Equipment Description
	Lettering	Vehicle shall be lettered with appropriately identifying as Traffic Unit, or Fire Police etc. with a minimum of reflective striping/lettering on all sides.
1	Vehicle	Unit must be equipped with red lights & siren compliant with current standards (other applicable legal combinations such as white, amber, or blue may be added).
1		First Aid Kit, Hand Sanitizer, Gloves, Pocket Mask
1		County Map Book and GPS
1		DOT Haz-Mat Emergency Response Guidebook (ERG) (Phone App also recommended)
1		Incident Command Board (Dry Erase or equivalent, with markers)
1		Fire Extinguisher - Dry Chemical ABC, 20 lb. minimum
1		Binoculars
2		Hand-held Portable Radios
4		Flashlights with red wands (or similar type light) with on-board charger or extra battery set(s)
1		MUTCD Compliant Arrow-board or Variable Message Board (30"x60" minimum)
2		Safety Helmets with Reflective Trim (minimum ANSI Type I)**
4	Vests	ANSI Class 2 or 3 Traffic Vests
2		Stop/Slow Paddles. Sign Must be 18", reflective and have a 6ft. Staff. (24" Recommended)
2	Signs	"Road Closed" signs (Rectangular Sign, 48" x 30", White with black letters)
2	Signs	"Incident Ahead", or other similar initial advanced warning signs, e.g. "Emergency Ahead"
2	Signs	"Be Prepare to Stop" warning signs *
2	Signs	"___ Lane Closed Ahead" Advance Warning Signs* with overlays (Right, Left, Center, Turn, Exit, One, & Road)
2	Signs	Pictorial Lane Merge Signs*
2	Signs	Pictorial Flagger Sign*
8	Stands	Stands for above signs

1	Kit	LCFPA Approved Detour Kit Includes the following: 2 Detour Signs with Arrows (30" x 24") * 18 Coral Trail Blazer arrows signs, to attach to signs, poles, etc. Accompanying hardware & straps to fasten 2 End Detour Signs (24" x 18").
2	Cases/ Kits	Emergency Road Flares. E-Flares (Recommended) or Fusee type flares
60	Cones	28"-36" Penn Dot PUB 213 compliant Traffic Cones with Reflective collars
4		Barricades (minimum of 270 sq. in. reflective striping per barricade).
2	rolls	Barrier Tape, "Do Not Cross" (2000' minimum)
1		Portable Lighting Equipment for the illumination of TCP's***
1		Portable Generator for providing power to TCP's, Scenes, or to power Traffic Signal Lights

* Must be 48" Diagonal, D.O.T. approved, Fluorescent Pink color (existing orange signs acceptable until unusable). Recommend equipping each sign with 2 orange flags.

** Recommend Team Wendy SAR BACKCOUNTRY or equivalent, Economy alternative - Klein Tools Safety Helmet 60145 with reflective lettering/trim.

*** Recommend portable free standing lights with battery in addition to generator lights.
